

## Privacy Policy

This Privacy Policy applies to all of the services offered by Us. We are committed to protecting individual privacy and securing the personal data made available to us when you access or use Our App.

Please review the entire Policy and feel free to contact us using the contact information below if you have any questions. By downloading the App or using any of our Service, you consent to our collection, storage, use and disclosure of your personal data as described in this Privacy Policy. If you are not pleased with this Privacy Policy you should not use our App.

This Privacy Policy doesn't apply to: (i) the information practices of other companies and organizations that advertise our services; (ii) services offered by other companies or individuals, including products or sites.

We do not intentionally collect personal data of persons under 18 years old. If you are under 18 years old please do not send us your personal data (for example, your name, address and email address). If you are under 18 years old and you wish to ask a question or use this Website in any way which requires you to submit your personal data please get your parent or guardian to do so on your behalf.

### 1. Data Collection

- A. Contact information (such as name, email address, cell phone number );
- B. Player name and password (such as account ID, account name);
- C. Profile information (such as profile photo);
- D. Other data you choose to give us (such as data to identify a lost account);
- E. Data about your account and game progress;
- F. Your IP address and mobile device identifiers (such as your device ID, advertising ID, MAC address, IMEI, UDID, Android\_Id);
- G. Data about your device (such as device name and operating system, browser type, language, brand, version, model);
- H. Data we collect with cookie and similar technology (see more below);
- I. General location data;
- J. Data about your use of the Service, such as gameplay data and your interactions with other players inside the Service;
- K. In most cases, we also create a specific ID for you when you use the Service;
- L. Data we receive if you link a third party tool with the Service (such as Facebook, Appsflyer);
- M. Demographic data (such as to determine the coarse location of your IP address);
- N. Data to fight fraud (such as refund abuse in games or click fraud in advertising);

O.Data from platforms that the games run on;

P.Data for advertising and analytic purposes, so we can provide you a better Service;

If you object to providing any personal data, it may be possible for you to use portions of the App. However, if you need to utilize all features of the App, including without limitation, receiving payments (if any), it may be necessary to provide the personal data.

## 2. Purpose of Collecting Data

We only use this data for statistical purposes, and not in a manner that would give us sufficient data to identify you personally. We use this data to provide you with our Services. For example:

A.To make the Service work;

B.To show personalized advertisements;

C.To keep the Service safe and fair;

D.To determine if the App is working properly;

E.To make changes to the App that allows users to have better experiences and improve the App, our offers and promotional content so that they are more relevant to you;

F.To make sure that we comply with applicable legal requirements.

## 3.Data Protection

In order to protect your personal data held with us and third parties we work with, we use industry-standard physical, procedural and electronic security measures, including encryption where deemed appropriate. We take reasonable measures to help protect your data from loss, theft, misuse and unauthorized access, disclosure, alteration and destruction.

## 4.Data Retain

We retain the data we collect for different periods of time depending on what it is, how we use it, and how you configure your settings:

Some data you can delete whenever you like, such as the content you create or upload. You can also delete activity information saved in your account, or choose to have it deleted automatically after a set period of time.

Other data is deleted or anonymized automatically after a set period of time, such as advertising data in server logs.

We keep some data until you delete your Account, such as information about how often you use our services.

And some data we retain for longer periods of time when necessary for legitimate business or legal purposes, such as security, fraud and abuse prevention, or financial record-keeping.

When you delete data, we follow a deletion process to make sure that your data is safely and completely removed from our servers or retained only in anonymized form. We try to ensure that our services protect information from accidental or malicious deletion. Because of this, there may be delays between when you delete something and when copies are deleted from our active and backup systems.

## 5. Data Share

If you provide us with personal identifiable data, we may share necessary data with other affiliate company, so as to serve you in the most efficient and effective way unless such sharing is prohibited by law.

We work with a variety of third parties and service providers such as third party subcontractors, affiliates of us, retailers, fulfillment partners and marketing partner to help provide you with our Services and we may share data with them to support these efforts. For example, companies we've hired to provide data analytic services may need to collect and access personal data to provide those functions. In such cases, these companies must abide by our data privacy and security requirements, and follow Apple's Privacy rules.

This Privacy Policy applies only to data collected through the App, and for data provided offline. If the user links to outside websites, please review their posted Privacy Policies.

## 6. Your Rights

You have rights to restrict us to collect and use your personal data, which may include the rights:

- A.To update and correct your personal data. You can also contact us and ask us to update or correct your data.
- B.To request access to and a copy of your personal data;
- C.To request erasure of your personal data;
- D.To restrict or object to collection and using of your personal data;
- E.To withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal;
- F.To exercise any of your rights, please contact us. We may ask you to verify your identity, and act upon your requests in accordance with applicable laws.

When you are located in the EEA, your personal data will be transferred to recipients in countries located outside the EEA, which do not provide a similar or adequate level of protection to that provided by countries in the EEA.

## 7.Special Provision

When you are located in the European Economic Area (EEA), you will have following additional rights:

- A.To ask for a copy of your personal data to be provided to them, or a third party;
- B.To lodge a complaint about the processing of your personal data with your local data protection authority in the EEA.

You hereby expressly consent to the transfer of your personal data to recipients, as described in this Privacy Policy, which are located outside the EEA. You may withdraw your consent at any time.

We do not knowingly collect personal data about children under the age of 13 (in EEA is under the age of 16). If a parent or guardian becomes aware that his or her child has provided us with data without their consent, he or she should promptly contact us and we take reasonable steps to ensure that such data is deleted from our files.

## 8.Privacy Update

We reserve the right to make changes to this Privacy Policy at any time. We may update this Privacy Policy from time to time in order to reflect, for example, changes to our privacy practices or for other operational, legal, or regulatory reasons. If we make material changes to this Privacy Policy, we will give you notice of such changes by posting the revised policy on the App or our website, and where appropriate, by other means. By continuing to use the Service or our website, after these changes are posted, you agree to the revised policy.
